The meeting was opened at 7:40pm

1) <u>Apologies for absence</u> There were apologies for absence from Jenny Lowless and Judith Scott.

2) Adoption of Minutes

GM pointed out that the amendments to the Constitution mentioned in item 6 are still under consideration and the minutes have been changed to reflect this. The minutes of the May 23rd meeting were thus adopted.

3) <u>Matters Arising</u>

4) <u>Officer's Reports</u>

5) <u>SIVC Website</u>

PR said that he will no longer be hosting the clubs website from next year but will arrange transfer as necessary. The committee granted permission for him to use the SIVC website to try out some experimentation.

6) <u>Conference 2019</u>

PR said that there had been a lot to do recently but that he is still planning on doing a write-up of the aIVC Conference for distribution to the rest of the membership.

7) <u>Christmas 2019</u>

BR said that he had been contacted by Best Western at Copdock with a view to booking a Christmas party this year. The price is still about £35 but they are experimenting with a £10 reduction for midweek dates. It was decided to go with this venue with a view to booking on a Friday or Saturday before the end of November. It was also agreed to adopt last month's suggestion of giving a £10 discount on the price to every member who comes along.

8) <u>Events</u>

GR's event in the in The Hare and Hounds on June 20th had been cancelled due to lack of attendance but she planned to try again on Tuesday 23rd July. GM said that he was planning to advertise a Car Cruise in Lowestoft for which a write-up had already been sent to BR.
